
What is Mental Health First Aid?

The initial help given to a person showing symptoms of mental illness or in a mental health crisis (severe depression, psychosis, panic attack, suicidal thoughts and behaviors. . .) until appropriate professional or other help, including peer and family support, can be engaged.

An 8-hour course (formerly was 12 hours) prepares members of the public to provide Mental Health First Aid to those in need. This course is delivered by certified Mental Health First Aid USA instructors who complete a 5-day training and meet other



- The prevalence of mental illnesses in the U.S. and their emotional and economic cost.
- The potential warning signs and risk factors for depression, anxiety disorders, trauma, psychotic disorders, eating disorders, and substance use disorders.
- 5-Step Action Plan (ALGEE) is to help an individual in crisis connect to professional care.
- Resources available to help someone with a mental health problem.

NOTE: There will be a cancellation fee of \$20.00 if you do not give a required 7 days notice and/or if you do not show up for a class you are registered for.

Who is eligible to take this training for FREE? This Training is available at no cost due to a grant awarded by the Michigan Department of Community Health (MDCH), until 9/31/2014. This training targets and trains laypersons that work and/or interact with youth (i.e. parents and foster care givers, educators, faith community/clergy, health care providers, law enforcement, juvenile justice workers, and other interested laypersons in Battle Creek, Clinton, Eaton, Ingham, Genesee, Kalamazoo, Kent, Muskegon and Saginaw counties. Most everyone meets the criteria if you are in the region listed!

Nursing-Community Mental Health Authority of Clinton-Eaton-Ingham Counties, OH-336 (expires:3/1/2015), is an approved provider of continuing nursing education by the Ohio Nurses Association (OBN-001-91), an accredited approver by the American Nurses Credentialing Center's Commission on Accreditation. Nurses participating in MHFA training may receive a maximum of 7.5 CE hours.

Social Work-The Michigan Association of Community Mental Health Boards, provider #1140, is approved as a provider for social work continuing education by the Association of Social Work Boards through the ACE program. MACMHB maintains responsibility for the program. ASWB approval period (11/10/13-11/10/16). Social Workers should contact their regulatory board to determine course approval. Social Workers will receive 7.5 continuing education clock hours for participating in this Mental Health First Aid (MHFA) Training.

Substance Abuse Professionals- MACMHB is approved by Michigan Certification Board for Addiction Professionals (MCBAP). MACMHB maintains the responsibility for the program and content. Substance Abuse Professionals participating in this Mental Health First Aid (MHFA) Training may receive a maximum of 7.5 "related" educational contact hours.
